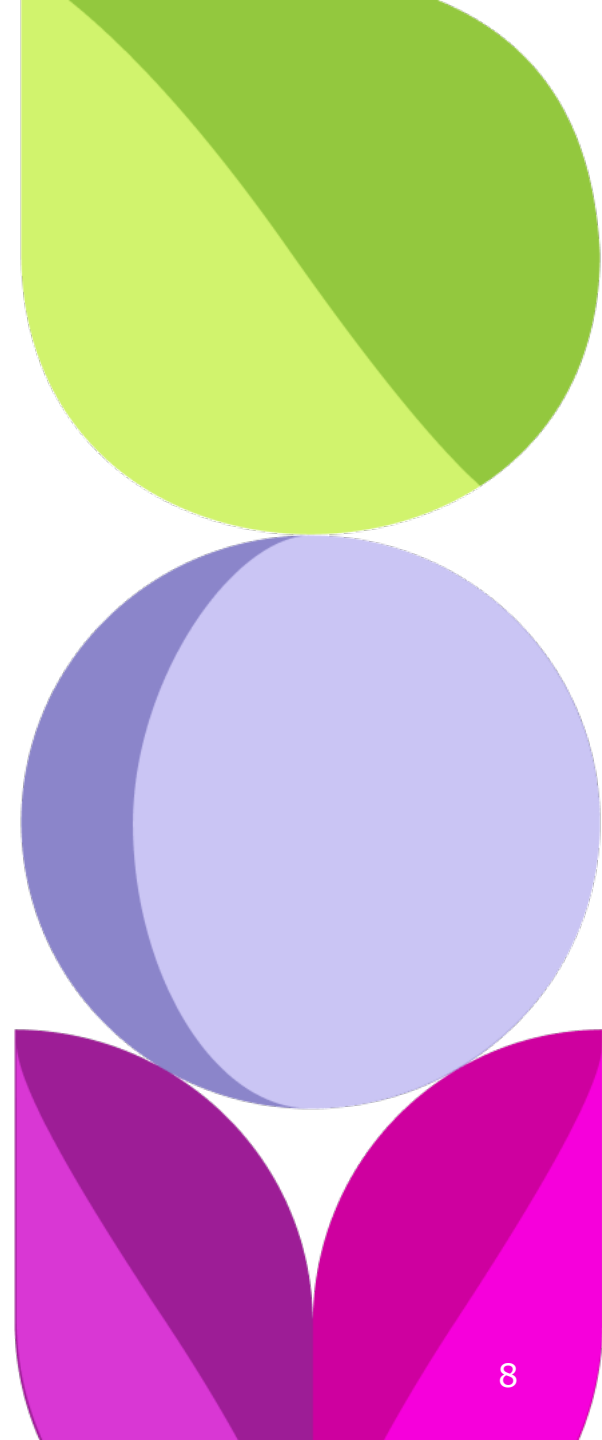

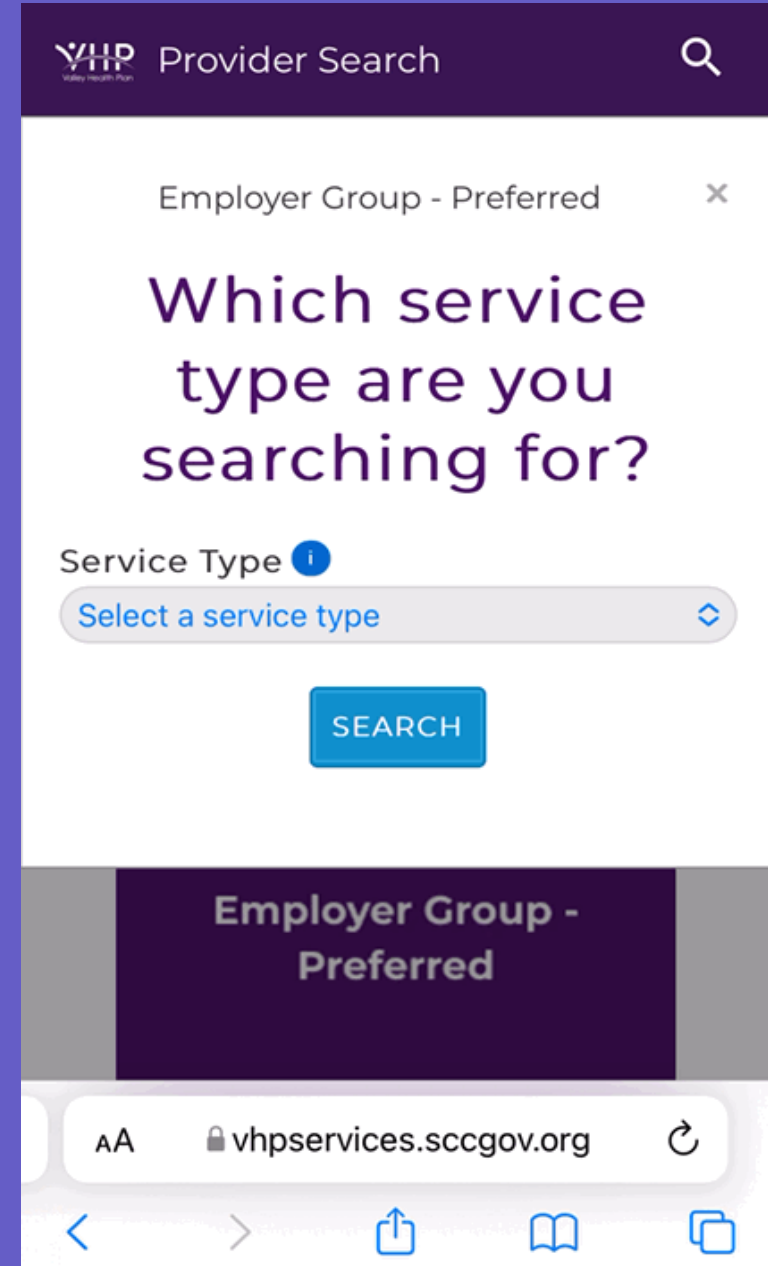

# Behavioral Health Services



Expanded network includes MDLIVE for therapy and medication management.



No authorization is required for outpatient therapy or visits with psychiatrists.



Case management program to support the member.



# Referrals & Prior Authorizations

- PCP generates a referrals and Prior Authorization requests.
- A written approval/denial will be sent to the member and the PCP.
- VHP processes a routine request in 5 days and an urgent request in 72 hours.

**No referral or prior authorization is required for outpatient mental health and substance use services from an in-network, contracted, plan provider, including Psychiatrists.**

No referral is necessary for primary, behavioral, prenatal or OB/GYN care; diabetes management; or Urgent care services.

# Additional Information – Medicare

- If active members are Medicare eligible, they and their Medicare-eligible dependents, must enroll in Medicare Part A when the member turns age 65.
- When retired Medicare members must enroll in Medicare Part B as well.

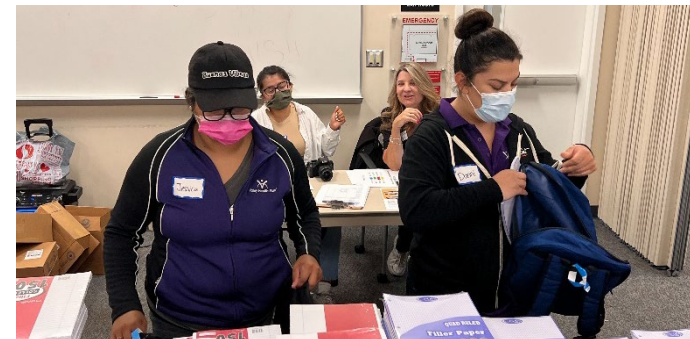

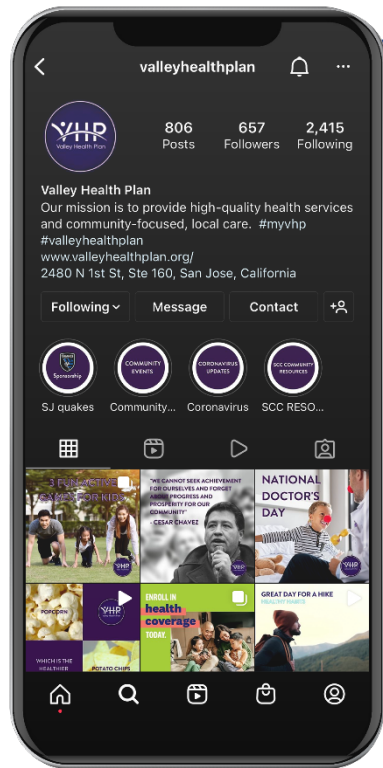
