Subject: You Can Log into VHP Access Now!

Dear Site Administrator,

Valley Health Plan (VHP) is launching Epic Tapestry's provider portal – branded as **VHP Access** – on March 1, 2023, as a replacement to VHP's current Valley Express system. You have been identified as the Site Administrator for your organization. The **Site Administrator** is the primary contact working with VHP to manage user adds, terminations and modifications to a user's access.

During the transition, it is important that VHP configure the system to allow users to access the system and to confirm the role each user will perform. Effective 02/03/2023, VHP Access will be available for provisioning of user accounts for your organization. Instructions for you to log into VHP Access are set forth below:

- **1.** Log into VHP Access at: www.vhpaccess.org.
- **2.** Sign into the portal with the following information:

Username: FIRSTNAME.LASTNAME

Temporary Password: Welcome2vhpaccess!

(You will be asked to change your temporary password once you log into VHP Access.)

3. Agree to the terms of the VHP Access User Agreement.

Once a user's account has been requested, each user will receive a notification from VHP to activate their account. Please note that if you do not request user accounts by the launch of VHP Access, March 1, 2023, users will not be able to access their accounts to conduct important activities on behalf of your organization.

Following user account creation, VHP will offer live and virtual training sessions to individuals you have identified as users of **VHP Access**. VHP will share more information regarding the **VHP Access** portal launch and training opportunities over the next several weeks.
