## PURPOSE OF THE REPORT

The **BHSD 4537 OPEN CLIENTS BY CCP ADM PGM** report displays the client's admission date from the admission program, primary diagnosis, as well as the client's first and most recent service date within a service program. If claims have not been approved in MSO, the client's first and most recent service date may not be represented.

This report pulls all clients that are currently open to the Admission Program.

Enter the County Contracted Provider in **Provider** and select the Admission Program in the **Program** field.

When the report is processed, the open clients are listed under the service programs they have been billed and approved for. If the client falls under the N/A section, it indicates the client has been admitted into the Admission Program, but no services have been billed and approved yet.



## BHSD 4537 Open Clients by Adm Program

**Notes:**

1. Display all open client's admission date from the admission program, primary diagnosis, and client's first and most recent service date in a service program.
2. Clients listed 'N/A': Clients that have a program admission, but no registered services within myAvatar yet (may be awaiting batched services from 837 submissions).
3. Length of Stay (LOS) is days between Admit Date & Report Run Date.
4. Age is based on Report Run Date.
5. As this report is coming directly from the County instance of myAvatar, the service dates will be as up to date as the claims process for any given agency (837s are generally submitted on the 12th of each month for the prior month).

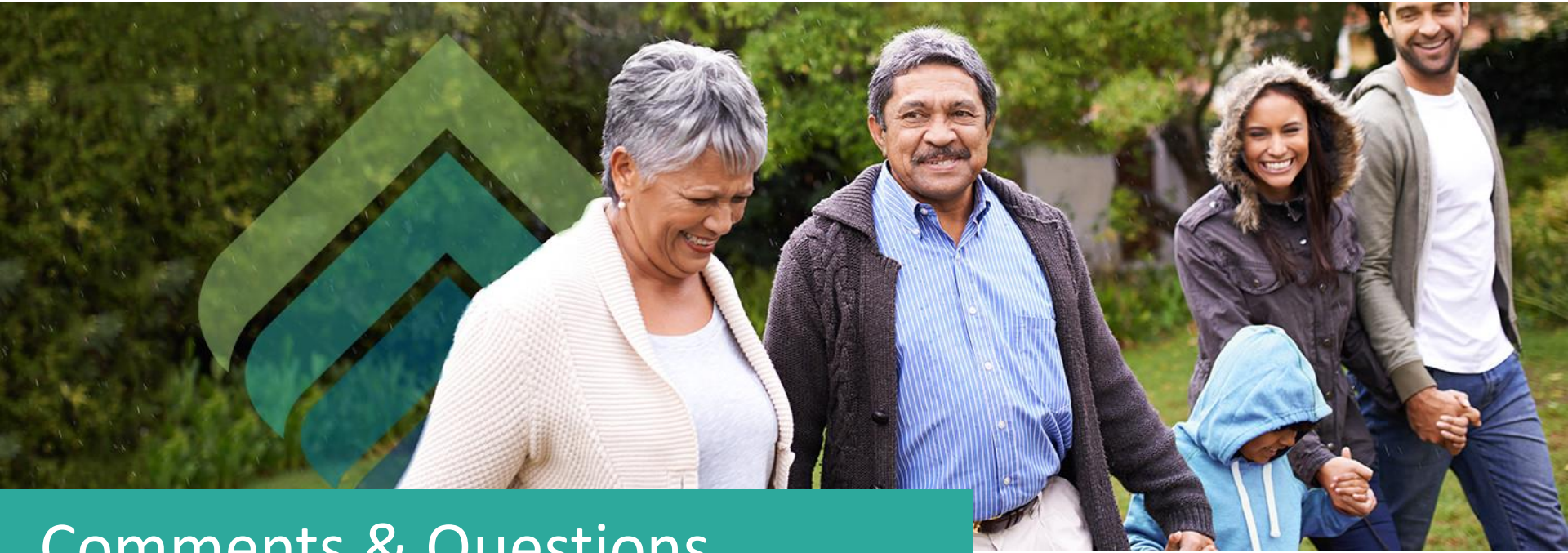
