- Thank you for your continued service with the County of Santa Clara.
 It's important to know that your County benefits continue to be here for you.
- For the 2024–2025 plan year, there are no material changes to the County's benefit plan offerings. This means you can continue with the coverage you currently have, without interruption.
- However, if you do wish to make changes to your benefits coverage or to receive the Health Care Bonus Waiver, Open Enrollment runs May 1-31, 2024.
- Your benefit elections will take effect June 24, 2024.

What You Need to Know for 2024-2025



- You'll see changes to premium rates for medical coverage, but almost all benefit plans and features remain unchanged.
 - The County is introducing an enhanced and expanded employee assistance program (EAP) through Concern.
- We recommend you review your current benefit selections and covered dependents to make sure your benefits continue to meet your needs.
- No action is needed unless you want to make a change or continue receiving the Health Care Bonus Waiver next year.
- If you want to make benefit changes, complete your **enrollment form online** by May 31, 2024.

Telemedicine



All the County medical plans offer telemedicine at no cost to you.

Doctors can diagnose and prescribe medication, just like an in-person office visit.

- Virtual visits are available—by phone or video—with a licensed doctor or therapist.
- You can make appointments by web, phone, or mobile app.
- Appointments are available 24 hours a day, seven days a week.
- You can use telemedicine as an alternative to expensive ER or urgent care visits or for any nonemergency health concerns.
- Mental health support is available (depending on the plan).

Vision



Vision Service Plan (VSP) is your vision provider.

You have a choice of which vision provider to see for care, but if you visit a VSP provider, you will receive the following benefits:

- \$20 exam copay
- Lenses every 12 months at no cost
- \$120 allowance for frames every 24 months
- Contact lenses covered up to \$120 every 12 months in lieu of glasses, including the exam

Other County Benefits—No Action Required

The County offers additional benefits that don't require you to take action during Open Enrollment:


- Flexible Spending Accounts

 - Deferred Compensation Plan, including new Roth 457(b) Option
 - Retiree Medical coverage

Other County Benefits—No Action Required

NEW! Roth Governmental 457(b) Option

Beginning in May 2024, your Deferred Compensation Plan is expanding to include Roth contribution options. Your current plan lowers your taxable income by allowing you to contribute on a pre-tax basis. Roth contributions, on the other hand, are taxed as regular income before being added to your account. Then, in retirement, your Roth contributions and earnings are generally tax-free.


Health Care Bonus Waiver



You have the option to receive a taxable increase in gross wages by waiving the County's medical coverage.

- Full-time employees who elect to waive medical coverage receive \$74 per pay period in taxable wages.
- Part-time employees receive a prorated amount.
- You must provide proof that you are enrolled in another health plan to qualify for the Health Care Bonus Waiver.
- You must reelect to participate during the 2024–2025 plan year.

COMPLETING YOUR ENROLLMENT



Only Enroll if You Want To...

- Enroll in medical, dental, or vision coverage if you are not currently enrolled
- Change your current medical or dental plan election if you are already enrolled
- Enroll or reenroll in the Health Care Bonus Waiver program
- Add or drop coverage for eligible family members

Completing Your Enrollment



- Visit the <u>Employee Benefits web page</u> to complete your <u>enrollment</u>
 <u>form online</u>, or contact your department's <u>Employee Service Center</u>.
- Submit your form no later than May 31, 2024.
- Benefits effective date is June 24, 2024.
- Payroll deduction changes begin with your June 28, 2024, paycheck.


