II. Reports and Updates

 2024 Presidential Primary and General Election Updates – Claudia Gonzalez, Candidate Services Division Supervisor

March 5, 2024, Presidential Primary Election (VCA): Nomination period ended December 13, 2023. The qualified list of candidates can be found online at www.sccvote.org. The write-in candidacy period begins January 8, 2024 – February 20, 2024.

November 5, 2024, Presidential General Election (VCA): Nomination period opens on July 15, 2024. Offices that will be included are state and local run-off candidates, school boards, special districts, and city candidates.

Vote Center Updates: 104 vote centers will be available throughout the Santa Clara County. Weekend voting will open two full weekends for before Election Day with 23 vote centers open from 9am – 5pm. March 2, 2024, the remaining of the vote centers will open. Election Day hours on March 5, 2024, will be from 7am – 8pm. Sharpies will be available at every vote center. A sharpie marker ensures the ink dries immediately and it's safe to cast your ballot onto the scanner at any vote center. Touch screen voting and audio ballots are available at every vote center. Paper, touchscreen, and audio ballots are available in 9 languages. Facsimile paper ballots are available in 5 languages. Vote centers have a process in place to assist American Sign Language (ASL) voters. In case an interpreter is needed, the vote center staff will call the 299-poll number and inform them about the location of the voter. If the voter has a smartphone, we can connect them with assistance through our contracted service. This service not only provides ASL interpretation but also other languages.

Vote centers are in compliance with county health policies, providing hand sanitizers and free masks.

AB626: Vote centers have a process in place for voters to cast their vote by mail ballot.
