- 2. Mail the signed and completed statement to our office in the enclosed postage-paid envelope.** It must be received by our office no later than **18 days after the election, Saturday, April 26, 2025**. Postmarks will not be accepted.
- 3. Fax the signed and completed statement to our office.** It must be received no later than **18 days after the election, Saturday, April 26, 2025**. The fax number is (408) 998-7314.
- 4. In person at the Registrar of Voters' Office.** You may come to our office at the address below, Monday through Friday 8:00 AM to 5:00 PM to SIGN your original Provisional Ballot envelope or return the Identification Envelope Statement. This must be done no later than **18 days after the election, Saturday, April 26, 2025**.

Note: The signature provided may be added to your voter record for signature comparison purposes in future elections.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign and return this statement by the deadline means that my provisional ballot will be invalidated.
