OFFICIAL BALLOT

This ballot stub shall be torn off by  
precinct board member and handed to the  
voter.

To vote for any measure, place the  
ballot card on a flat, hard  
surface. Press the tip of the punching  
instrument against the center of the  
circle which appears to the right of  
the word "YES" or to the right of the  
word "NO" and slowly lift the bottom of  
the ballot card until the circle  
completely detaches from the card.

All distinguishing marks or erasures  
are forbidden and make the ballot  
void. If you wrongly punch, tear or  
deface the ballot card or tear or  
deface the write-in ballot envelope,  
return it to the precinct board member  
and obtain another.

After voting insert the ballot card  
into the write-in ballot envelope and  
return it to the precinct board member.

MEASURE SUBMITTED TO VOTE OF VOTERS

A shall an initiative ordinance be  
enacted which:

(1) Immediately reduces the tax on the  
provision of utility services from 5%  
to 2.5% for a period of twelve months  
following said reduction and terminates  
said tax entirely at the end of the  
twelve month period; and

(2) Prohibits any local government  
within the City of Morgan Hill from  
imposing any tax upon the provision of  
utility services following the  
reduction and termination of the  
present tax unless and until such  
is submitted to the electorate of the  
local government and approved by a  
majority vote of the voters?
