

CalAIM Rollup Services and Duplicate and Distinct Modifiers Guide

CalAIM Rollup Services

In the most current SMHS and DMC-ODS Billing Manuals the State defines Duplicate Services.

Application

Based off of the State's definitions, we created a column next to each CPT/HCPC code, "Allow Duplicate Services on the Same Day". If we filter the column to "No" then we need filter out the "Maximum Units/Day" to exclude a maximum unit of "1". A code with a maximum unit of 1 makes it impossible to rollup multiple services but report 1 unit.

For MH: See below for service codes and their permutations that will need to be rolled up if they are provided at multiple times throughout the day by the same provider to the same client. The State does not consider modifiers to make a service code unique, thus, any service codes below regardless of their modifiers will need to be rolled up.

* - These services provided in an individual setting need to be rolled up, but if provided in a group setting (as indicated by an HQ modifier) they do not need to be rolled up and can be provided multiple times per day without being considered duplicates.

For SUTS: See below for service codes and their permutations that will need to be rolled up if they are provided at multiple times throughout the day by the same provider to the same client. The State does not consider modifiers to make a service code unique, thus, any service codes below regardless of their modifiers will need to be rolled up.

* - These services provided in an individual setting need to be rolled up, but if provided in a group setting (as indicated by an HQ modifier) they do not need to be rolled up and can be provided multiple times per day without being considered duplicates.

CalAIM Duplicate Modifiers (76 and 77):

In the most recent SMHS Billing Manual the State specifies that the only service in which modifiers 76 and 77.

Application

Based off of the State's definitions, we created a column next to each CPT/HCPC code, "Allow Duplicate Services on the Same Day". If we filter the column to "Yes" then we need to filter down to the CPT/HCPC codes that allow any of the duplicated modifiers (76 and 77).

For MH: only S9484 Crisis Stabilization: Emergency Room & Crisis Stabilization: Urgent Care allow 76 and 77 modifiers. This would mean that if a client came into a Crisis Stabilization program, left, and returned once/multiple times, staff would need to use the appropriate modifiers on the services rendered during the return visit(s).

For SUTS: There are no codes that allow a 76 and 77 modifier.

CalAIM Distinct Modifier (59):

In the most recent SMHS and DMC-ODS Billing Manuals the State defines Distinct Services.

Application

Based off of the States' definition, practitioners may need to provide the same service to a client on the same day as a distinct/independent service. The use of modifier 59 is the appropriate way to identify the second service as distinct/independent from the first service.

For MH and SUTS: Use the CPT/HCPC Code Set to see which codes the State allows the 59 modifier to be used.
