July 1, 2024, Redemption Deadline Approaching for Delinquent 2023-2024 Annual Secured Property Taxes

*****Disregard This Notice if Your 2023-2024 Secured Property Taxes are Paid*****

SANTA CLARA COUNTY, CALIF. – This is to advise you that in May 2024, the County of Santa Clara mailed Delinquent Notices to property owners who have not paid their Annual Secured and/or Supplemental Secured Property Taxes in full for tax year 2023-2024. It's important to pay your property taxes on time to avoid penalties and to maintain quality of life in Santa Clara County. Property taxes funds many essential services, such as fire, police protection, education, and health and welfare services.

Delinquent taxes for 2023-2024 will default if payment is not received or postmarked by the U.S. Postal Service by Monday, July 1, 2024.

In accordance with State law, on Tuesday, July 2, 2024, the County will impose additional fees and penalties on the defaulted taxes. If residential property remains tax defaulted for more than five years, the County will sell the property at a public auction.

Please note that California Revenue and Taxation Code Section 2610.5 does not relieve you of the responsibility of making timely payments due to failure to receive your tax bill.

Paperless Billing

We encourage you to consider going paperless. It is an environmentally friendly and secure way to access essential property tax-related information, including assessed property values, tax bills, and payment options. To opt for paperless billing, visit www.sccassessor.org/optin.
