## **New Debit and Credit Card Transaction Fee Effective July 1, 2024**

**SANTA CLARA COUNTY, CA.** – This is to advise you that on July 1, 2024, the fee for debit card and credit card transactions will be reduced from 2.25% to **2.22%** with a minimum of \$1.49 per transaction. This is a convenience fee charged by the County's vendor. The fee will only be assessed when payment is made by using a debit or credit card. Paying by eCheck will continue to have no fees on the transaction. It is free to pay by checking account.

It is an environmentally friendly and secure way to access essential property tax-related information, including assessed property values, tax bills, and payment options.
