Rules for eligibility determination remain unchanged.



HEALTH COVERAGE - MEDI-CAL*

Medi-Cal benefits will continue without change for March, April and May 2020, unless you have been notified otherwise.

If you receive a Medi-Cal Annual Renewal packet, please complete and return. If you do not return the forms, your Medi-Cal benefits will end June 2020.

FOOD ASSISTANCE - CALFRESH FOOD*

CalFresh Food benefits will continue without change for March, April and May 2020, unless you have been notified otherwise.

- Semi-Annual Report (SAR7) due in March, April or May has been waived, no SAR7 report will be due during this period. SAR7 reporting requirements will resume in June 2020.
- Work requirements for Able-Bodied Adult without Dependents (ABAWD) have been suspended effective 4/1/20 until further notice, you do not have to participate to keep your benefits.
- Annual Renewals due in March, April or May have been moved six months from the original due date.

EMERGENCY CALFRESH FOOD BENEFITS

Emergency CalFresh Food benefits for March and April will be increased to the maximum benefit amount.

People in Household	Maximum Benefit Amount
1	\$ 194
2	\$ 355
3	\$ 509
4	\$ 646
5	\$ 768
6	\$ 921

For example, if you are a single person currently receiving \$140 per month, you will get an additional \$54, for a maximum benefit amount of \$194.

Emergency CalFresh Food benefits will be automatically put on your EBT card on April 12 and May 10, 2020.

CalFresh Food households already receiving the maximum benefit amount will not receive any emergency CalFresh Food benefits.
