NOTICE OF EXTENSION OF TIME

On February 21, 2023, Counsel for the County of Santa Clara (County) filed a Motion for an Extension of Time to Answer the Complaint filed by the Aircraft Owners and Pilots Association (AOPA), et al. pursuant to 14 CFR § 16.19(e). The Motion requested that the County's time in which to file its response to the Complaint be extended by 45 days until April 14, 2023.

The County raises three points to support the Motion; first, the County maintains that it is in active negotiations with the Federal Aviation Administration (FAA) that could moot some or all the issues raised in the Complaint. The County notes that it entered into a memorandum of understanding (MOU) from the FAA on February 7th that addresses issues raised in the Complaint. Secondly, the County states that preparation of a pleading before its desired extension date of April 14, 2023, would be difficult due to prior commitments by counsel. Lastly, the County argues that a short delay will not prejudice the Complainants.

The Complainants filed their opposition to the Motion for extension of time on the same day, February 21, 2023. In the interest of compromise, the County is hereby granted a 25-day extension, through and including Monday, March 27, 2023, to file its response to the Complaint.


