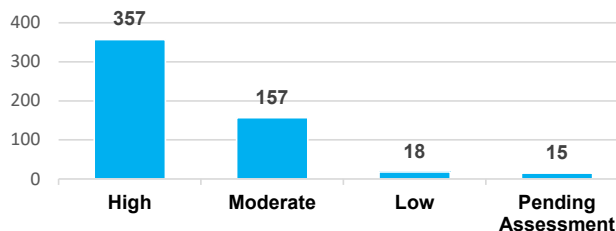

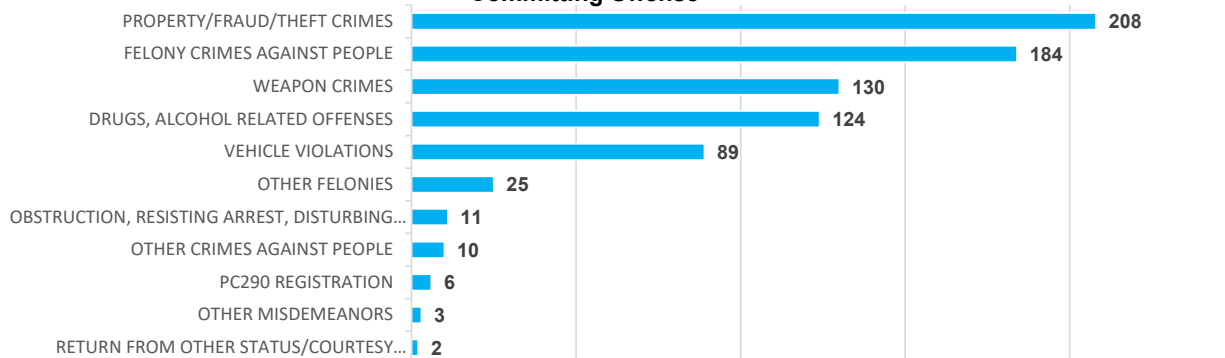
Age
