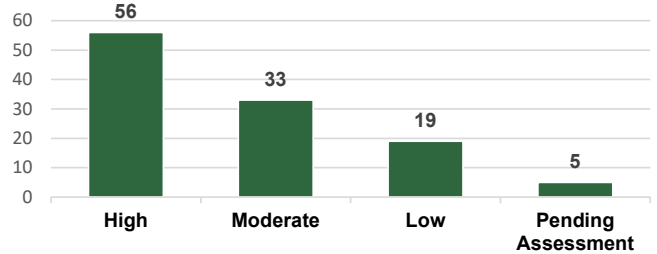

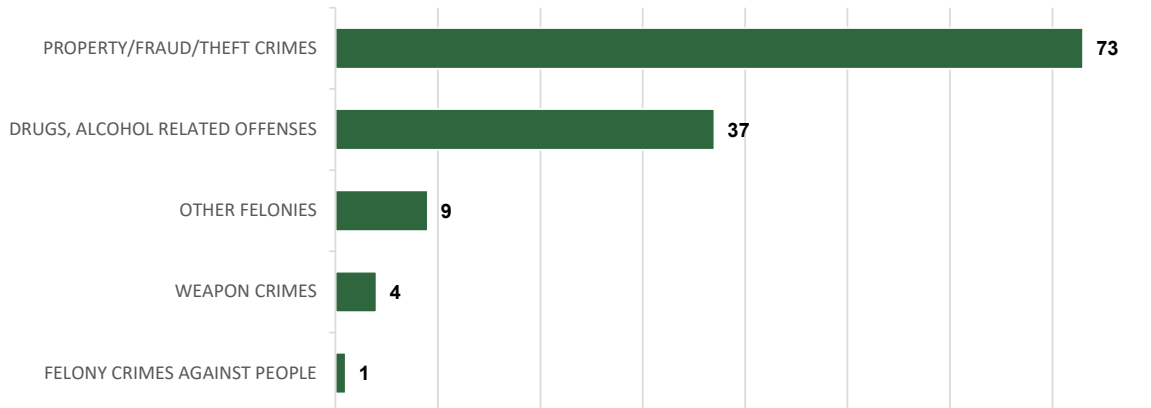
Age
