<b>DATES</b>	<b>ACTIVITIES / DOCUMENTS</b>
February 8, 2019  May 7, 2019  (E – 90 to E)	<b><u>CONTRIBUTION/INDEPENDENT EXPENDITURES REPORT</u></b>  Sums over \$1000 to/from a single source must be reported within 24 hours. The Independent Expenditure report is required only for committees (not candidate committees) that make independent expenditures totaling \$1,000 or more to support or oppose a single candidate or a single ballot measure.
February 8, 2019  (E – 88)	<b><u>DUE DATE FOR MEASURE RESOLUTIONS AND TAX RATE STATEMENTS *</u></b>  Last day for jurisdictions to file a resolution calling for a measure election, and if applicable, tax rate statement.
February 12, 2019  (E – 84)	<b><u>DUE DATE FOR ARGUMENTS *</u></b>  Deadline set by the Registrar of Voters for submitting arguments in favor of and against a measure.
February 19, 2019  (E – 77)	<b><u>DUE DATE FOR REBUTTALS AND IMPARTIAL ANALYSES *</u></b>  Deadline set by the Registrar of Voters for submitting rebuttals to arguments in favor of and against and the impartial analysis.
March 28, 2019  (E – 40)	<b><u>F.P.P.C. 1<sup>st</sup> PRE-ELECTION STATEMENT DUE</u></b>  Deadline for financial disclosure report Form 460 covering the period of __January 1, 2019__ to March 23, 2019_____.
April 8, 2019  (E – 29)	<b><u>FIRST DAY FOR MAILING OF VOTE BY MAIL BALLOTS</u></b>  First day for mailing of Vote by Mail ballots.
April 22, 2019  (E – 15)	<b><u>LAST DAY TO REGISTER TO VOTE FOR THE ELECTION</u></b>  Deadline to register to be eligible to vote in the May 7, 2019 election.
April 25, 2019  (E – 12)	<b><u>F.P.P.C. 2<sup>nd</sup> PRE-ELECTION STATEMENT DUE</u></b>  Deadline for financial disclosure report Form 460 covering the period of ____March 24, 2019__ to .__April 20, 2019_____
April 30, 2019  (E – 7)	<b><u>LAST DAY TO REQUEST VOTE BY MAIL BALLOT BY MAIL</u></b>  Deadline at 5:00 p.m. to submit a request for a Vote by Mail ballot to be mailed to voter.
MAY 7, 2019  (E)	<b><i>ELECTION DAY    MAY 7, 2019</i></b>

<b>June 6, 2019 (E + 30)</b>	<u><b>OFFICIAL CANVASS OF VOTE</b></u> Registrar of Voters to certify election results by June 6, 2019
<b>May 28, 2019***</b>	<u><b>School District, Community College District, County Board of Education, or Special District Elections:</b></u>  Conduct on the first Tuesday after the first Monday in November of odd-numbered years, no later than the last Monday before the last Friday of that month. EC§15372(a)

This calendar may not contain all of a candidate's or district's filing requirements. The Registrar of Voters Office is not open for filings on Saturday, Sunday or holidays.

\* The legal 10-calendar-day public examination period in which a writ of mandate may be sought begins immediately following the filing deadline for submission of those documents. The writ of mandate request shall be filed no later than the end of the 10-calendar-day public examination period.

\*\* The period covered by any statement begins on the day after the closing date of the last statement filed, OR January 1<sup>st</sup>, if no previous statement has been filed
