150 Airport Noise Compatibility Planning Study at Reid-Hillview Airport (RHV)

REASONS FOR RECOMMENDATION/BACKGROUND:

A FAR Part 150 Airport Noise Compatibility Planning Study implements portions of Title I of the Aviation Safety and Noise Abatement Act. It specifically establishes a single system for the measurement of airport (and background) noise, a single system for determining the exposure of individuals to airport noise, and a standardized airport noise compatibility planning program. The planning program includes (1) provision for the development and submission to the FAA of Noise Exposure Maps and Noise Compatibility Programs by airport operators; (2) standard noise units, methods and analytical techniques for use in airport assessments; (3) identification of land uses that are normally compatible (or non-compatible) with various levels of noise around airports; and (4) procedures and criteria for FAA approval or disapproval of noise compatibility programs by the Administrator.

The Federal Government requires a FAR Part 150 study be completed in order for an airport to be eligible for future airport improvement program grant funds including land-use planning projects, eligible noise attenuation programs and other airport projects. Unlike FAA capital improvement grants, the County would not be obligated to repay the FAA for this Noise Compatibility Planning Study grant in the event the airport were to cease operations.

CONSEQUENCES OF NEGATIVE ACTION:

The Federal grant offer will be withdrawn and future land use projects applicable to Reid-Hillview Airport will not be eligible for Federal funds.

STEPS FOLLOWING APPROVAL:

Step 1: Chairperson is to sign the resolution authorizing execution of agreement and sign part II acceptance.

Step 2: The Clerk of the board will forward the executed original and two copies of the grant agreement and the resolution authorizing execution of agreement to Roads and Airports Department at 101 Skyport Dr., San Jose, attention: Ms. Ruby Johnson.

Step 3: Staff will send the documents and fully executed agreement to the Federal Aviation Administration.
