H0009	Alcohol and/or drug services: Acute detoxification	Hospital inpatient  Acute detoxification may be used for patients who may be prone to life-threatening or critical conditions during the withdrawal process	LP, PA, NP, Pharma	<ul style="list-style-type: none"> <li>Document medical necessity for acute detoxification services</li> <li>Document services provided and intervention performed for acute detoxification</li> </ul>
H2015	Comprehensive community support services, per 15 minutes	Time spent providing community support services	LP, PA, Psy, LCSW, MFT, RN, NP, LPCC, AOD	<ul style="list-style-type: none"> <li>Time documentation for the use of this code is <u>each 15 minutes</u>. Specific documentation of time must be included.</li> <li>Document medical necessity for support services and description of the services provided</li> <li>Document assessment of the effectiveness of the services and progress towards the patient's goals</li> <li>Identify specific community support recommended for patient.</li> </ul>
H2017	Psychosocial rehabilitation services, per 15 minutes	Time spent providing PSR (psychosocial rehabilitation) services; individual or group services	LP, PA, Psy, Pharma, LCSW, MFT, RN, NP, LPCC, AOD	<ul style="list-style-type: none"> <li>Time documentation for the use of this code is <u>each 15 minutes</u>. Specific documentation of time must be included.</li> <li>Document and describe the specific activities performed to specifically enhance/support the patient's skills related to their specific rehabilitation needs and goals</li> </ul>
