COUNTY OF SANTA CLARA REGISTRAR OF VOTERS TO HOLD ELECTION ADMINISTRATION PLAN PUBLIC MEETINGS IN OCTOBER

SANTA CLARA COUNTY, CALIF. – The County of Santa Clara Registrar of Voters is inviting the public to attend one of two Election Administration Plan (EAP) public meetings to discuss proposed changes and give input or provide comments on the EAP. The EAP can be viewed and downloaded here in English, Chinese, Gujarati, Hindi, Japanese, Khmer, Korean, Nepali, Punjabi, Spanish, Tagalog, Tamil, Telugu, and Vietnamese.

In April 2019, the County of Santa Clara Board of Supervisors voted to adopt the Voter's Choice Act (VCA) model of voting. Under the VCA voting model, all voters in the county are mailed a Vote by Mail ballot at 29 days before the election, and Vote Centers open up 10 days before Election Day and are open to all voters within the county to vote in person. The two statewide elections in 2020 were the first VCA elections held in Santa Clara County. Under VCA, the County is required to have an Election Administration Plan (EAP) informing voters how elections will be conducted under the VCA model. This plan includes information about services available at Vote Centers and Ballot Drop-off Locations, information specific to voters who primarily speak a language other than English, and information regarding accessibility options for voters with disabilities. Under VCA, voters can choose when, where, and how to vote. With input from county residents, the County of Santa Clara Registrar of Voters developed the EAP in 2019 and is now inviting the public to comment on, or suggest any potential changes for future elections.
