## **NOMINATION PERIOD CLOSES THIS WEEK FOR JUNE 7, 2022 STATEWIDE DIRECT PRIMARY ELECTION**

**SANTA CLARA COUNTY, CALIF** – The nomination period closes this week Friday, March 11 at 5:00 p.m. for offices participating in the June 7, 2022 Statewide Direct Primary Election. The deadline may be extended to Wednesday, March 16 for contests in which an eligible incumbent officeholder does not file.

“This is the last week to file,” said Shannon Bushey, Registrar of Voters. “We urge candidates to file as soon as possible.”

Except for those running for City of San Jose offices, candidates may pick up and file nomination papers at the Registrar of Voters' Office, which is located at 1555 Berger Drive, Bldg. 2, Candidate Services Division, in San Jose. City of San Jose candidates – who have different filing requirements and deadlines – must pick up and file nomination papers with the Office of the City Clerk, which can be reached at (408) 535-1260.

Candidates must pay all required filing fees prior to issuance of nomination documents and, if applicable, pay any candidate statement deposits at the time nomination documents are filed.

Candidates are encouraged to file originally signed nomination documents, including a Declaration of Candidacy and nomination signatures, together in one packet with the County of Santa Clara Registrar of Voters' Office, Candidate Services Division no later than 5 p.m. on Friday, March 11, (or by Wednesday, March 16, if an eligible incumbent does not file) to qualify as a candidate.
