# NOMINATION PERIOD OPENS FOR NOVEMBER 8, 2022 GENERAL ELECTION

**SANTA CLARA COUNTY, CALIF** – The nominations period opens on July 18 at 8:00 a.m. for offices participating in the November 8, 2022 General Election. The nominations period closes at 5:00 p.m. Friday, August 12, and can be extended to Wednesday, August 17, for contests in which an eligible incumbent officeholder does not file.

The County of Santa Clara Registrar of Voters' office is providing candidates with both in-person and online support options for issuing and filing nomination documents during the nominations period. The purpose of the following options is to ensure candidates and county elections officials have a healthy and safe environment during the candidate nominations period.

- Options for Issuing Documents: appointment in-person; appointment online via video conference and secured OneDrive folder; by USPS mail; or walk-in
- ➤ If Choosing Issuance of Electronic Nomination Documents: submit a "Request to Receive Nomination Documents" form and set a video conferencing appointment or in-person appointment with an Election Specialist and discuss your options
- ➤ Options for Filing Documents: appointment in-person or walk-in; USPS mail; overnight delivery, or other delivery service; Authorization Form to Obtain/File Nomination Documents must be submitted before anyone other than the candidate can be issued or file papers. The form can be found online at <a href="sccvote.sccgov.org/candidates-measures">sccvote.sccgov.org/candidates-measures</a>; PLEASE NOTE: original, wet signed nominations documents must be submitted by the candidate, or person authorized in writing by the candidate. With exception to the Declaration of Candidacy that must be signed in-person at the ROV or witnessed by a notary public and mailed to the ROV: documents may be mailed, delivered by overnight courier, or filed in-person at the Registrar of Voters' office.
- ➢ If Choosing to File In-person: walk-ins will be welcomed; however, wait times may occur/vary and physical distancing requirements will be implemented the ROV is strongly encouraging candidates to use the electronic issuing options
- Eligibility to run for office must be completed before issuance of nomination documents

Candidates are encouraged to make an appointment and begin the nomination filing process as early as possible to ensure all paperwork is accurately completed and submitted on time.

"We expect an overwhelming number of candidate filings this November," said Shannon Bushey, Registrar of Voters. "We strongly encourage all candidates to file as early as possible. Our Candidate Services Division can provide you with all the resources you need to file successfully."

Candidates must pay all required filing fees prior to issuance of nomination documents and, if applicable, pay any candidate statement deposits at the time nomination documents are filed.

Candidates are encouraged to file originally signed nomination documents, including a Declaration of Candidacy and nomination signatures, together in one packet with the County of Santa Clara Registrar of Voters' office, Candidate Services Division no later than 5 p.m. on Friday, August 12, (or by Wednesday, August 17, if an eligible incumbent does not file) to qualify as a candidate.
