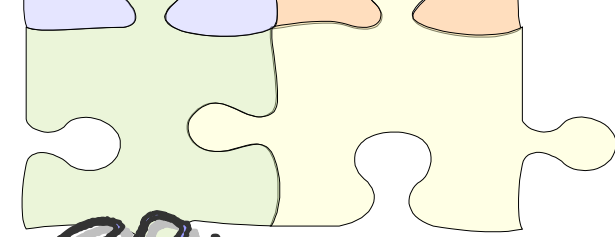

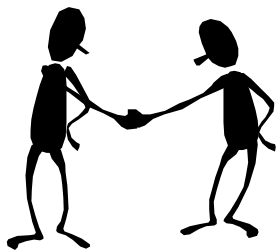

### **One Family's Story...**

My son was in jail again after numerous run-ins with the law. My husband and I felt we had done everything humanly possible to correct his uncontrollable behavior. Nothing worked. We had tried ALL the parenting courses we could find. Nothing helped. We were exhausted emotionally, physically and financially. So, when that call came to "try" The Parent Project, we were certain we didn't need it. There was nothing wrong with us... it was our *child*. I wasn't ready to say "Yes" to the caller on the phone that day. Frankly, I'd given up hope. After listening to me share my frustrations, he encouraged me to take whatever time I needed to decide whether this was a good fit for my family. Then he said one last thing: *What if there is one more thing in this class that you haven't heard before? And what if it's that one thing you need to hear to save your child?*

The next day my husband and I agreed to try the classes. In the first two weeks, I started to see small changes in our family and my confidence and hope grew. Well, four years after that call, my son finished High School (while still living at home) with strong grades and perfect attendance. He earned his way off probation, and was completely released from the judicial system. After graduation, he gave me a tight hug and said, *Thank you for loving me enough to not give up on me.*

I want to thank the Parent Project for showing me how to love my child again and to help him get his dreams!
