Re: December 4 item on the Board of Supervisors Agenda - Reid Hillview Airport

Dear Supervisor Chavez,

Uplift Family Services supports your recommendation to not accept additional FFA funding for the Reid Hillview Airport which would lock the County's use of the site as an airport the next 20 years.

With California's growing problem with lack of affordable housing, limited space to build new affordable housing, and the increase of children, families, and males experiencing homelessness, it makes sense that future Board of Supervisors be allowed the flexibility to determine the best and highest use of the site. We know that many of the families we serve experience homelessness or near homelessness and that our workforce requires affordable housing in order to stay in the area and provide the quality services they perform daily.

Uplift Family Services provides services in five (5) geographical regions throughout the state: Bay Area, Sacramento (including Contra Costa), Fresno, Los Angeles, and San Bernardino. We provide services to approximately 30,000 children and their family members annually, who experience severe mental health challenges and other significant behavioral health issues. We take pride in helping to create a robust system of care for children and youth, and are passionate about providing high quality and assessable behavioral health care for families in crisis.

It is for the reasons that we support Supervisor Chavez's recommendation to not "tie the hands" of future Boards in determining the future use of the site.

I regret that meeting conflicts will prevent me from attending the Board of Supervisors discussion on December 4 regarding County aviation facilities in general and Reid Hillview Airport specifically.

I write on behalf of LifeMoves, the largest provider of homeless shelter and services in Silicon Valley, to urge the Board to pursue a path that keeps all options on the table for the future of the Reid Hillview site.

It is vital that the Board have the flexibility to consider all potential uses for the site to best meet the needs of County residents, including the option of creating affordable housing to address the housing crisis in our community.

To preserve that flexibility so the Board can way all options in its decision making it is imperative that the County does NOT accept any FAA grants that would lock up the operations of the Reid Hillview site for decades to come.

Santa Clara County is known for a collaborative policy making process that includes the voices of all stakeholders, so we urge you to continue this tradition with regard to assessing the future of the Reid Hillview site by declining to pursue FAA grants and thereby keeping all options, including housing, on the table.




