# YOUR RIGHTS as a Survivor of Sexual Assault

### State of California Victim Compensation Program

- The California Victim Compensation Program (CalVCP) can help pay bills and expenses that result from certain violent crimes. Survivors of crime who have been injured or have been threatened with injury may be eligible for help. CalVCP Helpline: 800-777-9229 (phone) 866-902-8669 (fax)

NOTE: You may have to take part in the criminal case to qualify for CalVCB.

 You have a right to have a confidential sexual assault counselor (Victim Advocate) and a support person of your choice present during any exam or investigative interview. However, the support person may be excluded by law enforcement or the district attorney if it is determined to be detrimental to the interview. (Penal Code 679.04)

A survivor's immigration status does not affect their right to advocacy services and these services are offered at no cost to the survivor.

# SEXUAL ASSAULT SURVIVOR'S BILL OF RIGHTS

You have rights. You have the right to get answers, the right to information, and a right to know. This card explains your rights, options, and helpful resources available to you under California Penal Code 680.2.

You are not required to participate in the criminal justice system to receive a medical evidentiary examination.

Survivors of sexual assault and/or domestic violence are encouraged to report abuse to local police departments.

Local police departments are not ICE and you will not be reported to ICE as a survivor of sexual assault or domestic violence.

# YOUR RIGHTS as a Survivor of Sexual Assault

#### You Have the Right To:

- Request a person with a gender of your choosing to be present in the room during any interview with law enforcement or the District Attorney.
- Request in writing and receive a free copy of the initial crime report.
- Seek an Emergency Protection Order to help keep you safe. Ask a law enforcement officer if you would like one.
- Seek a Civil Protection Order with the support of a sexual assault counselor OR at the Family Justice Center at: 408-534-5600 or https://www.scscourt.org/self\_help restraining/rohc.shtml
- Know that DNA evidence on the body may last from 12 hours to 7 days. DNA and other evidence can breakdown over time due to exposure to heat, water, and other materials.
- Know the evidence related to your assault will be tested. By law, evidence should be taken to the Crime Lab within 20 days of booking and tested within 120 days of receipt or no later than 2 years from the date of the (last) offense.
- Know that evidence related to your assault must be kept for 20 years, or until age 40 for victims under age 18.
- Ask the status and results of the testing of all evidence related to your assault. For results contact the law enforcement agency investigating your case.

### Sexual Assault Forensic Evidence Tracking (SAFE-T)

Contact the California Attorney General's Victims' Services Unit for a general location and status of rape kit based on data entered into the SAFE-T database.

Request, in writing, sex offender registry information from the prosecutor, if your assailant is convicted and required to register as a sex offender.
